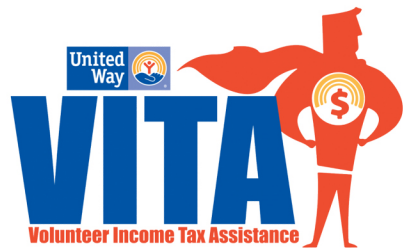

IF YOU MADE LESS THAN \$66,000 YOU MAY QUALIFY!

VITA helps eligible taxpayers obtain tax credits and deductions, especially EITC, child tax credit, education tax credit, and child care deductions. Anyone who files a basic tax return can have their taxes prepared at a VITA site for free.



Keep 100% of your refund by saving an average of \$250 or more on tax preparation fees. If you made under \$66,000 last year you can file a federal and/or up to three state tax returns electronically for free.

QUALIFIED CHARITABLE ORGANIZATIONS TAX CREDIT

As an Arizona resident you may be eligible for a tax credit up to
\$400 for individuals; or
\$800 for couples filing joint
